When using Information & Communications Technologies (ICT) at Welbourn School, I will always be a good digital citizen. This means that;

- Use the correct terms that I know ie: save, app, IWB, delete, Internet, search

5. I understand that I may experience problems when I use technology but I will learn to problem solve

- Passwords – I may make an error and need to try once again
- Take time for something to load
- See a buddy / ICT expert if I get stuck
- Check that devices are charged

6. I will always use ICT to communicate with others in positive, meaningful ways

- Think carefully about the words I use
- Make only positive and respectful comments about others work online

7. I will be honest and fair in all of my actions using ICT

- Be honest when I make a mistake
- Take turns and share fairly

8. I will always respect people's privacy and freedom of speech online

- T.H.I.N.K True, Helpful, Inspiring, Necessary, Kind
- Only use my own login

9. I will help others to become a better digital citizen

- Work collaboratively, buddies / digi expert
- Explain key words to others
- I know my work will always be there – this is a digital footprint
- If unsure, get an adult
